

1. Extension of the state of alarm

The RD 487/2020 of April 10th establishes the extension of the state of alarm previously declared by the RD 463/2020 of March 14th for the management of the health crisis caused by the COVID-19. Its duration will be extended until 00:00h on April 26th 2020.

2. Reactivation of non-essential activities

The new RD 487/2020 of April 10th establishes the extension of the state of alarm under the same conditions that were initially determined by RD 463/2020 of March 14th, which implies that the confinement of the entire population will continue. Displacements to supermarkets, pharmacies, banks or to workplace are still allowed. Bars, restaurants, commercial premises and shops will remain closed (as established in the **Annex** to RD 463/2020 of 14 March which is attached to this note). The following activities are allowed:

- Healthcare activities and/or operations
- Pharmacies
- Security activities
- Customs
- Telecommunications
- Media
- Distribution and marketing of food and basic needs
- Tobacco stores
- Gas stations
- Energy supply
- Public Transport
- Pet food stores
- E-commerce
- Laundries
- Companies and industries ancillary to the services described above
- Administration of Justice and services linked to this sector



Therefore, the only limitations established to the activity during the duration of the State of Alarm will be the same as those previously set out in the RD 463/2020 of Marc 14th.

3. Industry and construction

As of this Monday, April 13th, large sectors, such as industry and construction, will be allowed to develop its activity. However, this will be done under certain established limits, such as the obligation to comply with all the recommendations by the Government, as are maintaining the distance from other people of at least 2 meters, the



use of masks, gloves and/or any other means necessary to protect one's own health and that of others. Likewise, the development of presence-based activity is permitted for those sectors and/or jobs where teleworking or any other form of non-presential work is not possible.

In the specific case of the execution of certain works, Order SND/340/2020, of April 12th, suspends those works to be done in inhabited buildings in which there is a risk of getting infected by the COVID-19.

Finally, all those employees who present any of the symptoms of the COVID-19, those who have been in close contact with a person with such symptoms or are in a vulnerable situation due to age, pregnancy or previous medical conditions, should not attend their workplace, as long as this is a presence-based way of working. In the cases of teleworking, this does not apply.
